### 1 Right of Withdrawal for Consumers in Distance Contracts for Services/Delivery of Goods

#### 1.1 Right of Withdrawal\*

You may withdraw from this contract in writing

(e.g., letter, fax, email) within 14 days without giving any reason. The period begins upon receipt of this notice in writing,

but not before the contract is concluded and not before we have fulfilled our information obligations pursuant to

Article 246 § 2 in conjunction with § 1 (1) and (2) EGBGB, as well as our obligations pursuant to § 312g (1) sentence 1 BGB in conjunction with Article 246 § 3 EGBGB. To comply with the cancellation period, it is sufficient to send the cancellation in a timely manner.

#### 1.2 Consequences of Cancellation

In the event of a valid cancellation, the goods or services received by both parties must be returned, and any benefits derived (e.g., interest) must be refunded. If you are unable to return the service received and any benefits derived (e.g., benefits of use) to us, or can return them only in part or only in a deteriorated condition, you must compensate us for the loss of value to that extent. This may result in your still being required to fulfill the contractual payment obligations for the period up to the withdrawal. Obligations to refund payments must be fulfilled within 30 days. The period begins for you upon sending your notice of withdrawal, and for us upon its receipt. Items suitable for parcel shipping are to be returned at our risk.

You must bear the standard costs of the return shipment if the goods delivered correspond to those ordered and if the price of the item to be returned does not exceed 40 euros, or if, in the case of a higher price of the item, you have not yet provided the consideration or made a contractually agreed partial payment at the time of withdrawal. Otherwise, the return shipment is free of charge for you. Items that cannot be shipped by parcel post will be picked up from your location. Obligations to reimburse payments must be fulfilled within 30 days. The period begins for you upon sending your notice of withdrawal or the item, and for us upon receipt thereof.

\*The right of withdrawal does not apply to goods that are manufactured according to customer specifications or are clearly tailored to personal needs.

### 1.3 Special Notes

Your right of withdrawal expires prematurely if the contract has been fully fulfilled by both parties at your express request before you have exercised your right of withdrawal.
